It is our firm's policy to respect the privacy of all accounts that it maintains as an adviser and to protect the security and confidentiality of nonpublic personal information relating to those accounts. Please note that this policy applies to former clients as well as current clients.

G. DeWayne McAnally Does Not Sell Your Information

Whether you are a current or former client, our firm is committed to protecting the information you have shared with it. This commitment to conduct business honestly, and with your best interests in mind, is the foundation of this privacy policy.

Your Information Is Confidential

G. DeWayne McAnally's regulations require that customer information be held in the strictest confidence.

G. DeWayne McAnally Protects Your Information

Our firm maintains practices to ensure the security and confidentiality of your personal information. Our firm has building security, passwords to protect databases and information systems, compliance audits, and world-class virus/intrusion/spyware in place. Within our office, access to member information is limited to those who need it to perform their jobs.

Personal Information Collected

In order to service your account as your adviser, the firm G. DeWayne McAnally collects information from you in order to provide the financial services that you have requested. The information collected by our firm may come from the following sources:

- * Information received from you, such as your name, address, telephone number, social security number, occupation, and income;
- * Information relating to your transactions, including account balances, positions and activity;
- * Information which may be received from other sources with your consent

Sharing of Non-Public Personal Information

The firm G. DeWayne McAnally does not disclose nonpublic personal information relating to current or former clients to any third parties, except as required or permitted by law, including but not limited to any obligations of the firm G. DeWayne McAnally under the USA PATRIOT Act, and in order to facilitate the clearing of client transactions in the ordinary course of business.

Upon certain conditions when your account(s) is transferred out from the firm G. DeWayne McAnally, it may disclose your non-public personal information to the financial institution seeking to receive your account(s). This may occur under a number of scenarios, such as if our firm becomes affiliated with another firm, if our firm becomes a part of a merger or sale whereby your account is transferred to another firm, if our firm changes clearing

agents, or any other such arrangements in which provision of your non-public personal information will facilitate handling, transfer, or clearing of transactions necessary to effect the required changes.

Security

The firm G. DeWayne McAnally strives to ensure that its systems are secure and that industry standards are met. Our firm protects personal information that is provided to it by maintaining physical, electronic and procedural safeguards that either meet, or exceed, applicable law.

Our firm uses strict standards of care in handling the personal financial information of customers. As a general policy, its staff will not discuss or disclose information regarding an account except with authorized personnel of its clearing firm, Schwab Institutional, a division of Charles Schwab & Co., Inc., or as required by law or pursuant to regulatory request and/or authority.

Because our firm tightly controls how it shares your information outside of G. DeWayne McAnally, **you are already opted out of sharing outside of G. DeWayne McAnally** as allowed by local, state and federal laws.

If you have opted out with G. DeWayne McAnally, you do not need to do so again.
